

REVISED FEE SCHEDULE

We are making changes to our current fee schedule that will go into effect on May 13, 2024. It is never an easy decision to adjust our fees especially since we take pride in offering our members low interest rate loans, low fees and great interest rates on savings. - Outgoing International Wire Transfer \$65.00 (US Dollars to Foreign Currency) \$95.00 (US Dollars to US Dollars)
- Visa Debit Card Priority Shipment \$50.00
- GAP Insurance \$175.00

INACCURATE TRANSACTIONS

Have you purchased goods or services using your VISA Check Card (debit card) and noticed there was an error with the transaction? Maybe the merchant did not provide the goods or services you ordered or

you were not charged appropriately. There is a dispute process the Credit Union can assist with to safeguard you from dishonest or inaccurate behavior from a merchant. The Credit Union advises members to contact the merchant first to provide a credit or provide some other sort of remedy. If the merchant refuses to provide a refund in accordance with the sales agreement, you may have a valid claim to file a dispute.

It is important to retain all relevant correspondence with the merchant. In order to file a dispute, the Credit Union will ask you to try and provide the following documentation:

- How you contacted the merchant about the charge, for example: phone, email, live chats, letter or in person-(copies/screen shots of all correspondence)
- All dates of contact with the merchant including merchant contact name and phone number
- Detailed description of your attempt to resolve the dispute with the merchant
- Description of merchandise or goods ordered
- Sales slips / receipts
- Copy of proof of payment or credit voucher (cancelled checks, receipts or account statements)
- Date you expected to receive merchandise and/or tracking information
- Proof of cancellation / return cancellation number, cancellation policy acknowledgement, receipt for return shipping and tracking number

DESIGNATING BENEFICIARIES

Have you considered what will happen to your account in the event that something should happen to you? Naming a beneficiary on your account and IRA will eliminate unnecessary red tape when it comes time to settle your affairs. All it takes is a few key pieces of information.
