

SHARED BRANCHING GUIDELINES



InnerLakes FCU 232 Central Ave, Silver Creek, New York 14136 Open Monday – Friday, Noon – 5:00pm (Contact branch for holiday hours)

- Bring your current, unexpired ID with you to the InnerLakes Silver Creek Branch
- Bring a document that identifies you as a member of SUNY Fredonia FCU (receipt, bank statement, etc)
 - Complete a shared branching deposit ticket available in the lobby of the Credit Union

If a check exceeds \$500, the remaining amount must be deposited into your savings or checking account. 	4:00 pm - 5:00 pm**	 Withdraw up to \$200 in cash from your account. Cash a check up to \$200. If a check exceeds \$200, the remaining amount must be deposited into your savings or checking account. Tuesday	Noon - 2:00 pm*	 Withdraw up to \$500 in cash from your account. Cash a check up to \$500. If a check exceeds \$500, the remaining amount must be deposited into your savings or checking account. InnerLakes FCU is required to obtain verbal approval from SUNY Fredonia FCU for these transactions before processing.
	2:00 pm - 5:00 pm**	 Withdraw up to \$200 in cash from your account. Cash a check up to \$200. If a check exceeds \$200, the remaining amount must be deposited into your savings or checking account. SUNY Fredonia FCU is closed during this time, and no verbal approvals can be obtained for transactions over these limits.
Wednesday	Noon - 2:00 pm*	 Withdraw up to \$500 in cash from your account. Cash a check up to \$500. If a check exceeds \$500, the remaining amount must be deposited into your savings or checking account. InnerLakes FCU is required to obtain verbal approval from SUNY Fredonia FCU for these transactions before processing.

^{**}Transactions conducted at the InnerLakes FCU office outside SUNY FFCU's regular business hours may be posted on the next BUSINESS day. Additionally, funds deposited may not be available for VISA check card transactions until the following business day.
